

Hardware Installation


There are two methods to install the wire-less adapter:

- (1) Plug the wireless adapter into the computer's USB port directly.
- (2) Connect the wireless adapter with computer by using a USB extension cable&base. (Prior to buy USB base)


Note: When use it with desktop computer, suggest connecting it to any of the rear USB ports of the computer by using a USB extension cable&base, extending it to the desk for use, more effective. (Most destktop computers' front USB ports are unavailable or have power shortage)

2 Drive Software Installatiao

- (1). Put the CD into the drive, click the CD drive and find "Setup. exe", double click this application and operate the setup program.
- 2. Choose setup language click as show in the picture blelow:



3. Click Next to continue, as shown in the picture below:






5.After successful installation, computer system tray will appear icon (REALTEK client management software) at the lower right corner of the task bar.



3 Network connection Settings


(1) Double click the icon , open the wireless adapter's client management software, as shown in the picture below:




(2).Click "Available Network", choose the wireless network SSID which you want to connect, then click "Add to Profile", as shown in the picture below:



(3).Enter network key and confirm network key, click "OK", as shown in the picture below:



(4) After successful connection, the General interface will show Signal Strength and Link Quality, as shown in the picture as below:
