### 4. Hardware Installation

The following sections in this chapter describe how to install XG-630 Module

### 4.1. Installation Overview

XG-630 wireless module is design for Access Point, Router, ATU-R, Printer Server series, IP Camera series and Internet Video Server only.

### 4.2. Safety Recommendations

#### The safety guidelines are as follows:

- $\lambda$  Keep the board area clear and dust-free before, during, and after installation.

### 4.4. Installing a **XG-630**

- $\lambda$  Remove the XG-630 module from its protective packaging.
- *λ* Avoiding Electrostatic Discharge

Before you install the XG-630 module, ground yourself by touching a piece of metal to avoid electrostatic discharge (ESD). You should also take the following precautions to prevent damage to the XG-630 module:
