


1 Power/Diag LED








How to Set Up AirStation for the First Time

To configure your AirStation, follow the procedure below.

Notes:

- On your device, search for available networks and find the AirStation. If a password is required, enter the AirStation's encryption key.
- Your AirStation's default SSID and encryption key are on the setup card.

Opening Settings

To configure the AirStation, log in to Settings as shown below.

- 1** Launch a web browser.
- 2** Enter the AirStation's LAN-side IP address in the address field and press the enter key. The status page will be displayed.
- 3** When you click on a tab, the login window will pop up. Enter the username and password you previously set.
